Procedure FR-1 (Complete and sign the statement below.)

1. I was a resident of the Lithuania on the date of my arrival in the United States. I am not a United States citizen. I have not been lawfully accorded the privilege of residing permanently in the United States as an immigrant.
2. I am temporarily present in the United States for the primary purpose of studying or securing training required to qualify me to practice a profession or professional specialty at **Rowan University**.
3. I will receive compensation for personal services performed in the United States. This compensation qualifies for exemption from withholding of federal income tax under the tax treaty between the United States and the Lithuania in an amount not in excess of \$5,000 for any taxable year. I have not previously claimed an income tax exemption under this treaty for income received as a teacher, researcher, or student before the date of my arrival in the United States.
4. I will be present in the United States only for such period of time as may be reasonably or customarily required to effectuate the purpose of this visit.
5. I arrived in the United States on _____ (the date of last arrival in U.S. before beginning study at the United States educational institution). I understand that the treaty exemption under Article 20(1) is available only for compensation paid during a period of five taxable years beginning with the taxable year that includes my arrival date.

**INCOME TAX TREATY BETWEEN THE UNITED STATES OF AMERICA AND LITHUANIA FOR THE
AVOIDANCE OF DOUBLE TAXATION AND THE PREVENTION OF FISCAL EVASION WITH RESPECT
TO TAXES ON INCOME AND CAPITAL****ARTICLE 20(1)--Students, Trainees, and Researchers**

1. a) An individual who is a resident of a Contracting State at the beginning of his visit to the other Contracting State and who is temporarily present in that other Contracting State for the primary purpose of:
 - (i) studying at a university or other accredited educational institution in that other Contracting State; or
 - (ii) securing training required to qualify him to practice a profession or professional specialty; or
 - (iii) studying or doing research as a recipient of a grant, allowance, or award from a governmental, religious, charitable, scientific, literary, or educational organization, shall be exempt from tax by that other Contracting State with respect to the amounts described in subparagraph b) of this paragraph for a period not exceeding five years from the date of his arrival in that other Contracting State.
- b) The amounts referred to in subparagraph a) of this paragraph are:
 - (i) payments from abroad, other than compensation for personal services, for the purpose of his maintenance, education, study, research, or training;
 - (ii) the grant, allowance, or award; and
 - (iii) income from personal services performed in that other Contracting State in an aggregate amount not in excess of five thousand United States dollars (\$5,000) or its equivalent in Lithuanian litas for any taxable year.
