Lambda Tau Omega	1/29/24	Allegation that participation in hazing activities (not defined/described) is required for new members interested in joining.	Special Interim Campus Hearing Board found the organization not responsible: The organization did not take new members during this time period and it was found to be more likely than not that this report was falsified as retaliation for another matter.	Organization's National Governing Board issued a cease and desist 2/1 while an investigation was conducted. This was unfounded and rescinded.	3/6/24

Tau Delta Phi	2/8/24	A student was found intoxicated in a residence hall and told the responding staff members that he was forced to drink and do things that he cannot tell anyone by the organization.	The Special Interim Campus Hearing Board for Organizational Conduct determined that the preponderance of information did not support a finding of responsibility as no new member process was (formally or otherwise) conducted.	Interim organization suspension issued 2/9 while an investigation was conducted. The suspension was rescinded after the Campus Hearing Board process.	3/1/24
Alpha Chi Rho	3/24/24	Allegation that new members were forced to drink and do physical activities that could result in harm on or around 2/15/2024.	AXP officers interviewed. Alpha Chi Rho did not successfully recruit any new members this semester. No information to corroborate any allegations found.	N/A - not charged with potential violation	4/16/24
Tau Delta Phi	3/24/24	Allegation that new members were forced to drink, do physical activities that could result in harm, and are subjected to morally degrading activities on or around 2/18/2024.	The Special Interim Campus Hearing Board for Organizational Conduct determined that no specific hazing allegations were substantiated.	The Special Interim Campus Hearing Board found the preponderance of information did not substantiate finding Tau Delta Phi responsible for any of the charged violations.	7/26/24
