PART II: PLEASE REVIEW THIS LIST OF TRAVEL WARNING

There are many travel warnings for international students. Don't travel out of the U.S. if ...

- Page two of your I-20 is not signed by a designated school official.
- You don't have a visa for the country you want to visit and they require one from citizens of your country.
- You are in process of changing your status.
- Your I-20 is in terminated or completed status.
- You are in the process of reinstatement.
- Your OPT is pending or has been approved but you do not yet have a written job offer, you will not be able to reenter the US.
- You are at or near the end of your program or OPT.

Note: If your US visa has expired, you will need to renew it to re-enter the US

PART III: PLEASE REVIEW THIS LIST OF REQUIRED TRAVEL DOCUMENTS FOR RE-ENTRY INTO THE U.S.

- Valid passport
- Valid visa
- Valid I-20 signed for travel on page 2.

If you are on OPT, you will need the following additional documents:

- EAD card
- Letter from the employer confirming that you are either employed or have been offered employment.

Note:

- I-20 form is valid for travel if signed by the Designated School Official on page 2 within the past year. OPT Travel signature is only valid for six months.
- Drop off your I-20 along with this travel form at the front desk of the International Center. It will be signed and ready for pick up in 2 working days.
