1

EXHAUST CHASE & PIPING CHASE REPAIR, FILL IN OPENINGS W/ 2 1/2" METAL STUDS & 5/8" GYPSUM BOARD. REFER TO MEPP DRAWINGS. ALIGN W/ AND MATCH ADJACENT FINISHES.

2

PROVIDE AND INSTALL NEW WINDOW INSECT SCREENS. REFER TO DETAILS ON SHEET A-002.

3

NEW PIPE AND/OR MECHANICAL CHASE W/ 2 1/2" METAL STUDS & PAINTED 5/8" GYPSUM BOARD - REFER TO DETAILS ON SHEET A-702.

4

NEW ENLARGED OPENING/LINTEL - REFER TO LINTEL SCHEDULE ON SHEET S-102.

5

ALL MONITOR LOCATIONS TO HAVE PLYWOOD BLOCKING SUBSTRATE.

6

INFILL VOID AT REMOVED DOOR/WINDOW WITH BATT INSULATION.

7

EXISTING WALL TO BE SKIM COATED AND PREPPED TO RECEIVE A LEVEL 4 PAINTED FINISH. ALL PATCHING AND REPAIRS ARE TO BE FEATHERED AND BLENDED TO ACHIEVE A SEAMLESS, UNIFORM APPEARANCE ACROSS THE ENTIRE SURFACE.

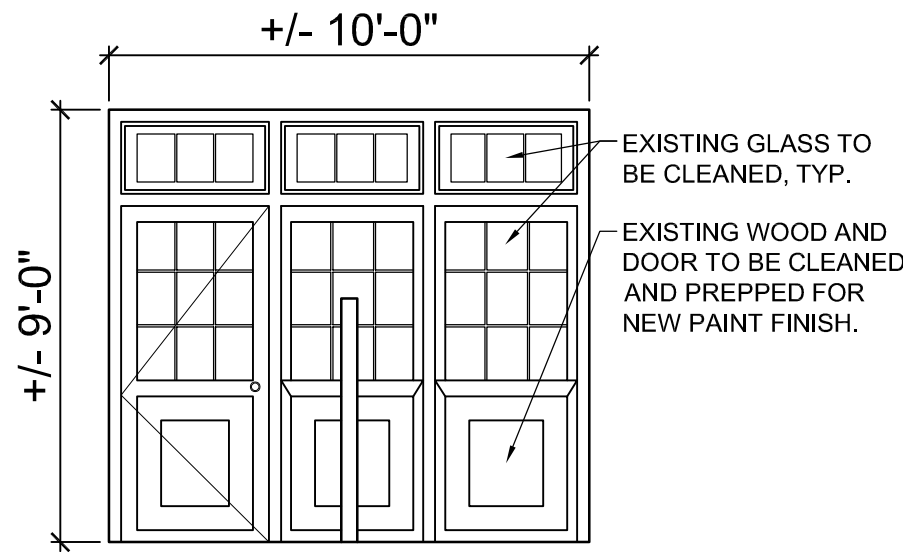

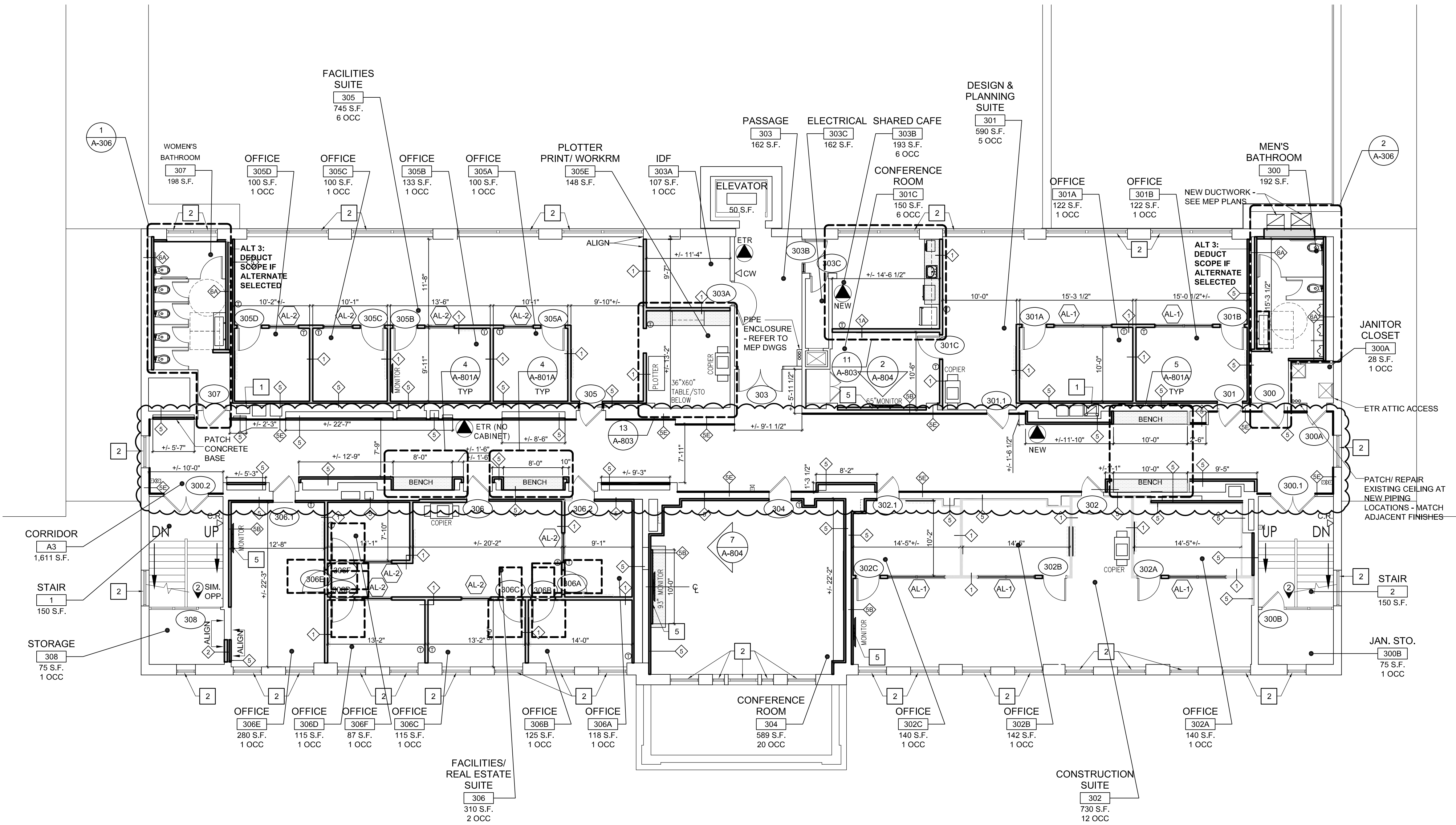


THIRD FLOOR

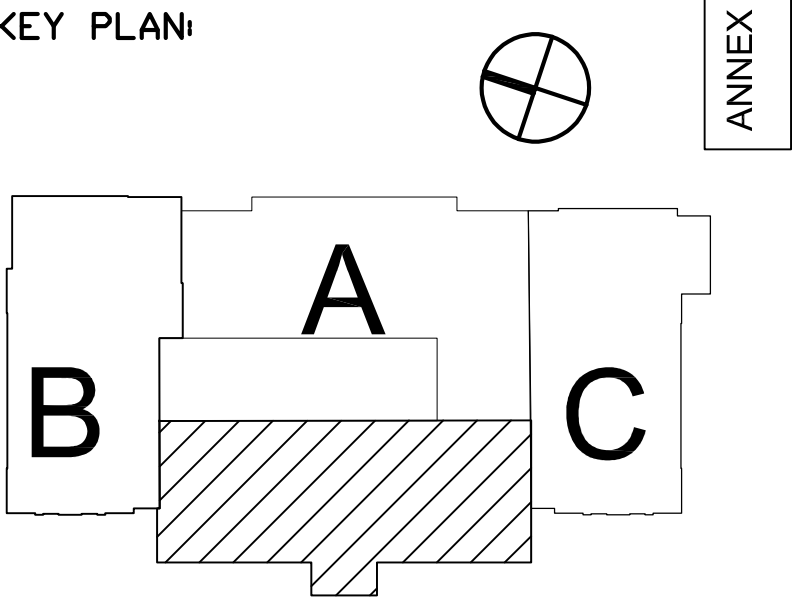
