AMENDMENT TO STUDENT INTERNSHIP AGREEMENT

THIS AMENDMENT, made effective as	of, 2020 (this "Amendment")
is by and between Rowan University, acting on b	ehalf of its Department of
a public research university within the system of H	ligher Education in the State of New Jersey, having its

Agreement originally dated as of	, 2020 by and between University and Facility
and University (the "Agreement"). All terms no	ot otherwise defined herein shall have the meanings
ascribed to such terms in the Agreement.	

WHEREAS, the current Agreement between University and Facility provides for experiential training opportunities for University's student interns at the Facility; and

WHEREAS, the Parties wish to amend the Agreement in the manner and form as set forth herein.

NOW THEREFORE, in consideration of the foregoing and the agreements below, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

1. The following section is added to RESPONSIBILITIES OF THE FACILITY:

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, the Facility must follow the strictest protocols and procedures laid out by federal, state, and local governments and federal and state health agencies to reduce the risk of the spread of COVID-19. No later than five (5) days prior to the commencement of a student's internship at the Facility, Facility must provide the University with a detailed and specific plan of how it intends to comply with all governmental requirements and recommendations related to the safety of student participation in the internship. University reserves the right to require specific procedures be implemented in order to best protect the health and safety of its students, faculty, staff, and the public.

2. The following section is added to MUTUAL RESPONSIBILITIES/GENERAL PROVISIONS:

The performance of this Agreement by either Party shall be subject to force majeure, including but not limited to acts of God, fire, flood, natural disaster, war or threat of war, acts or threats of terrorism, civil disorder, unauthorized strikes, governmental regulation or advisory, recognized health threats as determined by the World Health Organization, the Centers for Disease Control, or local government authority or health agencies (including but not limited to the health threats of COVID-19, H1N1, or similar infectious diseases), curtailment of transportation facilities, or other similar occurrence beyond the control of the Parties, where any of those factors, circumstances, situations, or conditions or similar ones prevent, dissuade, or unreasonably delay the internship, or where any of them make it illegal, impossible, inadvisable, or impracticable to implement the internship, or to fully perform the terms of this Agreement.

3. Except as specifically amended hereby, all terms of the Agreement remain in full force and effect. In the event of any conflict between the Agreement and this Amendment, the provisions of this Amendment shall prevail.
