## **I. PURPOSE**

This policy provides guidelines regarding the prohibition of smoking and the use of tobacco or tobacco-like products in university buildings and on university grounds in compliance with New Jersey state law and applicable regulations and in compliance with University policy.

## **II. ACCOUNTABILITY**

The President, the Vice President for Student Life and Dean of Students shall implement and ensure compliance with this policy.

## **III. APPLICABILITY**

This policy applies to all Rowan University faculty, staff, students, and visitors to all Rowan University campuses, buildings and grounds.

## **IV. DEFINITIONS**

1. *Electronic smoking device* - an electronic device that can be used to deliver nicotine or other substances to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, cigarillo, hookah or pipe.
2. *Smoking* - the burning of, inhaling from, exhaling the smoke from, or the possession of a lighted cigar, cigarette, pipe or any other matter or substance which contains tobacco or any other matter that can be smoked, or the inhaling or exhaling of smoke or vapor from an electronic smoking device.
3. *Smokeless Products* - Chewing tobacco (loose leaf, plug, or twist and may come in flavors); Snuff (moist, dry, or in packets [U.S. snus]); Dissolvable (lozenges, sticks, strips, orbs).

## VI. POLICY

1. New Jersey statutes state that the right of the non-smoker to breathe clean air supersedes the right of the smoker to smoke.
2. On the Glassboro Campuses, Rowan SOM and CMSRU smoking of tobacco products and the use of electronic smoking devices and the use of any tobacco or tobacco like product are prohibited by any person, any time, anywhere on any Rowan campus including all academic, residential, service, and administrative buildings, The effect of this Policy is to prohibit smoking not only in all buildings but also on all areas of college property. This means that smoking is prohibited on the grounds, playing fields, walkways, roadways, parking lots, in and around the perimeter of any building.
3. Smoking is prohibited in all University owned or leased facilities and vehicles.

4. *Electronic smoking device* - an electronic device that can be used to deliver nicotine or other substances to the person inhaling from the device, including, but not limited to, an electronic cigarette, cigar, cigarillo, hookah or pipe.

5. *Smoking* - the burning of, inhaling from, exhaling the smoke from, or the possession of a lighted cigar, cigarette, pipe or any other matter or substance which contains tobacco or any other matter that can be smoked, or the inhaling or exhaling of smoke or vapor from an electronic smoking device.

### VI. POLICY

4. New Jersey statutes state that the right of the non-smoker to breathe clean air supersedes the right of the smoker to smoke.
5. On the Glassboro Campus smoking of tobacco products and the use of electronic smoking devices is prohibited inside and within 50 feet of all academic, residential, service, and administrative buildings.
6. The Stratford Campus became smoke free on July 1, 2012. Smoking is prohibited in all University owned or leased facilities and vehicles.
