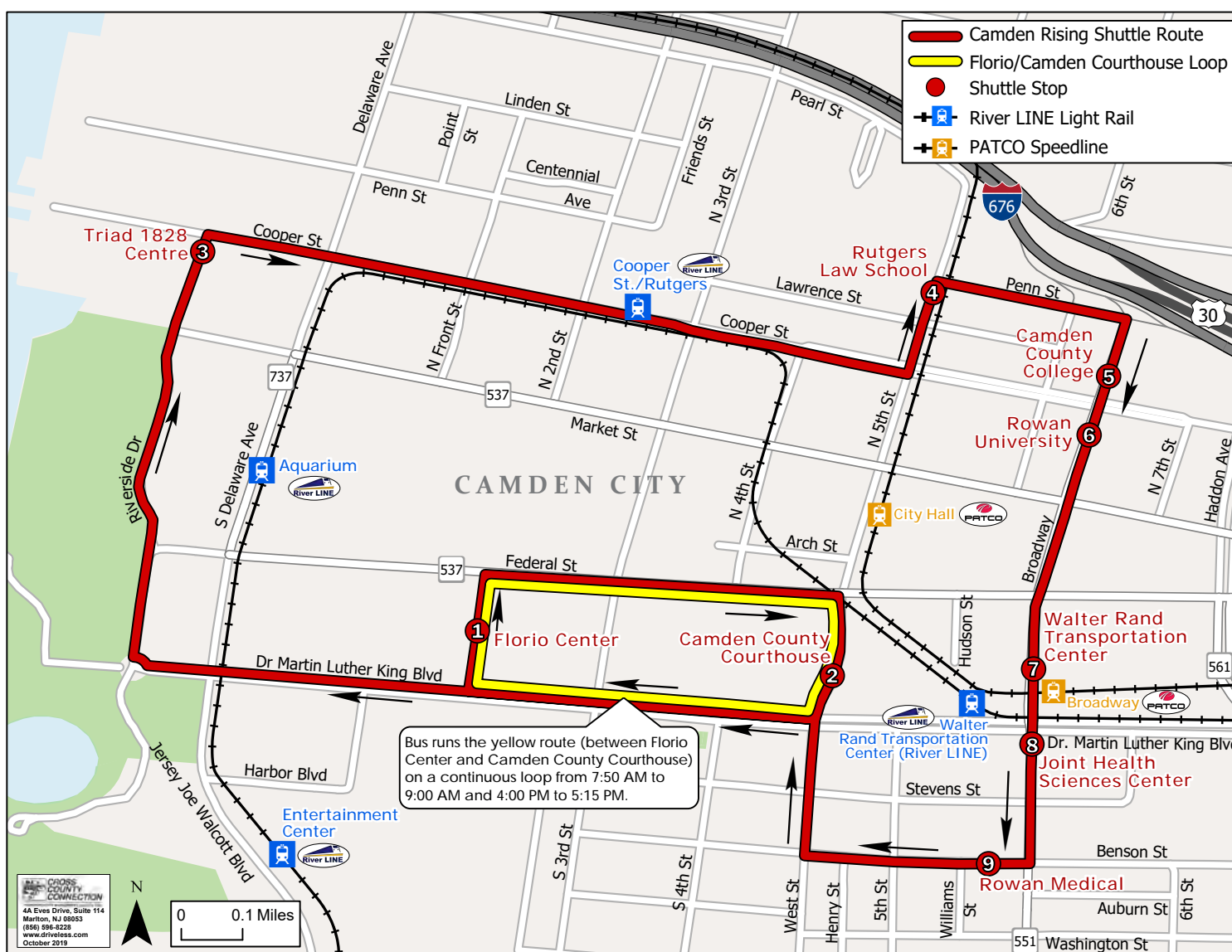

Attention Riders: Track the Shuttle with TransLoc Rider!

The Camden Rising Shuttle Tracker, an app available for both iPhone and Android devices, enables users to see a real-time location of the shuttle. This FREE app collects data from shuttle-mounted GPS units, and displays it on a map so riders can track the vehicles' locations. The app also features SMS text messaging of location information.

1. Download the TransLoc Rider App via Apple's App Store or Android's Google Play
2. Allow the app to access your location and select "South Jersey Transportation Authority Camden NJ"
3. Or select the "Routes" Icon in the main menu and search for Camden Rising and/or Camden Courthouse Loop
